Mr. Landon gave a brief overview to this item. Mr. Quinn provided a PowerPoint presentation, which is attached to these minutes.

CM Lewis-Prefers Option 1 as it is more efficient, in my opinion.

VM DeLorenzo-The transfers into the golf and tennis funds come from what portion of the general budget? Ans: Mr. Quinn-They come from the Park and Rec budget.

Public Comments:

Jack Carall-What are the expenses coming out for the pool and Indian Trails Sports Complex? Are they comparable to the golf and tennis courts?

Responses to Public Comment

Expenses: Ans: Mr. Quinn-With all of our Park and Recreation facilities, currently we do not track, for instance what the costs are specifically to maintain Ralph Carter Park or any of our individual park facilities, we do have some revenues from those facilities from rentals and things of that nature. We do not have separate P and L's on our parks. Primarily because the majority of the expense in those areas are covered

by general revenue or tax revenues. The same is true for the pool. We recover costs for use of the pool and it is fairly minimal and would not cover operating costs of the pool.

CM Ferguson-Option 1, we keep a minimum balance in the fund that we step up as a policy and if it were retained in the general fund do you feel it would be beneficial to us? Ans: Mr. Quinn-To meet the current fund balance policy for the Tennis and Golf Course fund, we would have to transfer about \$150,000 of the tax revenues that would simply sit in the bank in the Tennis and Golf Course fund that could not be utilized for other governmental needs. At this point since we are funding the Golf Course and Tennis Center as needed for any deficiencies in the revenues to have the money just sit there and not have the monies utilized for more important purposes is really the crux of Option 1, that does not make any sense.

Mayor Netts-Option 2 is blended whereas if we maintain option 1 we get our monthly reports from Kemper. Favors Option 1.

Mr. Landon gave a brief overview to this item. Mr. Rothwell provided a background summary to the prequalification process for this project.

Daniel Priotti-Thanked Council for the opportunity to appeal. How are the complaints being held against me when I am not the President of the company listed.

Mayor Netts-That is the essence of your appeal? Ans: Mr. Priotti-That and an email asking Jay Maher about Daniel Priotti and Agua Construction and yet a complaint from 8 years ago was brought up about another contractor.

Mayor Netts-Who is this other contractor? Ans: Mr. Priotti-Alberto Emilio Priotti, my father.

Mayor Netts-As I understand it there are three criteria for qualification. 1. You must be free of any substantiating complaints or violations during the past 2 years. 2. You must maintain a consistent record of passed inspections with no lengthy construction

delays during the prior two years.. 3. Have pulled permits and built or rehabilitated at least three homes within the last 2 years. Do you meet all three of those qualifications? Ans: Mr. Priotti-No, but I meet the probationary status.

Mr. Rothwell explained probationary status.

Mayor Netts-When did you start your company? Ans: Mr. Priotti-August 2, 2013.

Mayor Netts-Brian, how does that square with our probationary status? Ans: Mr. Landon-If I could, this is really where Beau comes in.

Mr. Falgout gave a background to the Neighborhood Stabilization Program.

Mayor Netts-Mr. Priotti-You have stated it was your fathers company where you were an employee and that you are not responsible; that I understand. But, what Beau points out is under this program, a homeowner applies, we put out bids-assuming we take the low bid, we give that information to the homeowner who then contracts with the contractor, in my mind there would be a presumption that if the City is presenting a homeowner with this name, they must know they are good; the analogy I use, is if you go up to Jacksonville and use a bus, you do not ask to see the driver's drivers license, you assume because it is a City bus that he must be properly licensed. I would think the same assumption would apply here. If we are giving you name as the low bidder to a homeowner, I think they would have a presumption that we have prequalified this individual, so the question is that prequalification or probationary status is that you have not met the three required permits for building or rehabing, do you you have sufficient experience that we could have confidence in your work? Ans: Mr. Priotti-I have worked for other companies besides my fathers. Such as the Stellar Group, the Haskell Group-all out of Jacksonville, commercial jobs. I have worked for other builders, other subs.

VM DeLorenzo-What license do you currently hold? Ans: Mr. Priotti-Certified General Contractor. VM DeLorenzo-What type of permits have you pulled under your company? Ans: Mr. Priotti-I pulled one in February, it is to build a pool and has work coming up for some homeowners for tornado damage.

CM McGuire-What is the management structure of your company? Ans: Mr. Priotti-I am the president and I have a silent partner.

CM McGuire-So, you have not had a chance to do enough jobs to be qualified? Ans: Mr. Priotti-Correct. CM McGuire-So, is it possible that this probation can be extended since he has not had the chance to prove himself under the auspices of his own company and divorced from his father's company? Ans: Mayor Netts-Not to jump in but he has not been granted probationary status. I think we all can agree that he does not meet the qualifications for general acceptance. There is a provision for probationary status.

CM Lewis-Can you tell me the probationary period for this applicant, has he enough experience in pools under the probationary period? Mr. Falgout-Based on my review probationary period was not permitted based on his experience. Mr. Landon-Once this new company pulls three permits without issues, he can qualify.

Mayor Netts-Since this is an appeal issue, do we need to open this up to the public? Ans:-Attorney Reischmann-This is a quasi-judicial item. As with any quasi-judicial item, if someone has an interest in the matter, they certainly can participate. There is recent case law that makes a distinction, I think we had a discussion about this recently about a participant versus a party. Obviously there are two parties in this

case, City staff and Mr. Priotti, but yes if someone who is not a party has something to say that is relevant, that would be substantial competent evidence, certainly that would be something this Council could consider in their quasi-judicial capacity. It does not have to but if someone has something, or a witness that would be appropriate.

CM Lewis-How do you get this experience as a probationary person other than getting a government contract? Ans: Mr. Landon-If he pulls 3 permits for work, then he is qualified.

Mayor Netts-What is probationary status? Mr. Falgout-It is not in the prebid, it is from the consultant, Guardian, and in speaking with them probationary status is bids less than \$15,000 and you are only allowed to have one at a time, where the regular program allows two at a time.

CM Ferguson-How many contractors are there now and how much business is available? Ans: Mr. Falgout-The program started in 2009 and we have qualified 40-50, some are out of business, some only do it once, the NSP is wrapping up and there are no longer any bids being awarded.

CM Lewis-Looking at the information provided, I did not find anything against Daniel, I see information against his father, I find that short of having a definition of probationary status, I find no reason why he cannot apply under that status.

VM DeLorenzo-What role in the company did you hold for those jobs you listed for previous experience. I am not sure what addresses they are talking about. Mayor gave the addresses. I managed putting the sub contractors together, ordering the supplies, where you in the field? Ans: Once in awhile.

VM DeLorenzo-Often in the construction company, there was someone who prepares for permits, call for inspections, was that your role? Ans: Mr. Priotti-Yes.

VM DeLorenzo-Was the issue that there was not a call in for final inspection? Ans: Mr. Falgout-Yes, and unfinished work.

Mayor Netts-One of his concerns is how the City conducted his review. Ans: Mr. Landon-Brian determined Mr. Priotti met the deadline and we are hearing his appeal. Mayor Netts-so that is a moot point.

Mayor Netts-Looking at the appeal, checking his experience. The experience is all pools. Little concerned with the probationary status-Mr. Priotti is saying he has met this status, inclined to approve probationary status.

VM DeLorenzo-I am of the same opinion, but more cautious as this is a new company, wish you luck, but there is a lack of experience here.

Mayor Netts-Is there anyone in the audience that has knowledge of Mr. Priotti's work? There were none.

CM Lewis made a motion and was seconded by CM McGuire to approve the probationary status. This motion was passed unanimously.
