CM McGuire-How much ahead (revenues related to building)? Ans: Mr. Quinn-About 25% ahead at this point (due to the actual volume of business).

CM McGuire-Staffing vacancy does that include the intended new hires for building inspectors? Ans: Mr. Quinn-No that is vacancies of people who were here at the beginning of the fiscal year that left for whatever reason and are in the process of being replaced and the overtime was to cover for when they are being replaced.

Mayor Netts-When we hit the recession, we did significant staff reductions, but now we are at a point where staff has more to do with less, are we staffed appropriately? Ans: Mr. Quinn-It is high on the radar especially in community development. There

are many positions being advertised to fill.

CM McGuire-Budget discussions-the glossary-can we print more? Ans: Mr. Quinn-Yes.

VM DeLorenzo-One thing we hear often during budget time is what is that? I did not know about that? Can we have that calendar available on the web too? Ans: Mr. Quinn-Yes.

CM Lewis-We need to get the glossary pamphlets out to the public as much as possible. How can we get this distributed more? Strategic review-there is a lot in there that will affect our budget, somehow we need to get more citizen participation.
