When they go vertical, they will pay Transportation impact fees and those impact fees will go towards paying off the loan and future improvements to the street in front of this project. This is the first step in starting to see some activity in the area.

Jack Carall-If the City decides to do away with the red light cameras and the State says no, can the State say no?

Richard Falbo-Polilticians and red light cameras.

#### Responses to Public Comment:

State-Mayor Netts-We have seen time and time again the legislature introduced themselves into home rule. Attorney Reischmann-In accordance with the Mark Wandall Act-cameras are not mandated by the Statutes. If a city chooses not to have red light cameras they have the discretion as what they do with red light cameras.

Red Light Cameras-Mayor Netts asked each member to state if they have received anything from ATS at any time. CM Lewis, Mayor Netts, VM DeLorenzo, CM Ferguson, Attorney Reischmann, Mr. Landon all responded they have not received anything from ATS at any time.

Cause of problem-Mayor Netts-That it's the careless drivers, the inattentive drivers, the drivers who exceed the speed limit, who do not maintain a safe distance between them and the car in front of them, they are the ones who cause the problem, not city council, not the red light cameras.

VM DeLorenzo-Seminole Woods-several accidents at corner of southern end of Sesame and Seminole Woods. Those traveling on Sesame do not realize the street is ending and wind up crossing Seminole and drive into the woods. Resident requested some reflective signs to alert drivers. Mr. Landon-We will take a look at it.

CM Lewis-Received a call about flags left on their property? Ans: Mr. Adams-It is a problem; state law only allows those who place the flags to remove them. The markings are good for 14 days.
