Mr. Landon gave a brief overview to this item. Ms. Santangelo provided a PowerPoint presentation, which is attached to these minutes.

Mr. Douglas White, Vice President of Casper Golf presented a PowerPoint presentation, which is attached to these minutes.

#### Public Comments:

CM Ferguson-Do you also manage the St. John's Golf and Country Club? Ans: Mr. White-We managed it for 4 1/2 years and we were able to buy that asset in 2009. CM Ferguson-What is the trend there? Ans: Mr. White-We acquired that assets when it was just under \$30 million and we were doing about \$500K in profit; we have been able to grow that over 20% in the past couple of years. St. John's has great potential.

CM McGuire-Have you surveyed the competition here in Palm Coast? How will you take business from the competition? Ans: Mr. White-We have to look at the demographics; the opportunity for Palm Harbor is to make sure we cater those individuals that are here tonight and playing now; price war on the outside play. We have to build loyalty and stay in tune with our players. The competitors are trying to win the price war. We focus on the value. We create loyalty programs for them to bring guests.

VM DeLorenzo-Have you looked at opportunity on the expense side? Ans: Mr. White-It is incremental. The quality of service cannot change. We see efficiencies.

Ben Blake, Executive Vice President of Kemper Sports-We have been here since day one and we are proud of what we have done. We focus on the local course and local community. We care about our customers; we get to know our customers. Community goal is to serve our customers. We focus on retention and relationships. We focus on trying to implement what is best for our customers and the local community. We appreciate the opportunity to serve our community and the opportunity to speak.

Jeff Yost, Down to Earth Golf-We are a lease company, not a management company. We can get you to break even within a year.

CM McGuire-Why do you want to take over a golf course that has been a money pit? Ans: Josh Yost-Running it like you own it, is different than running it like you manage it. We have costs that we will absorb that go to the bottom line. We do not see our budget going as high as what you are running at. There are rebates that we get as a

leasing company that do not necessarily get returned to cities, there are discounts but not rebates. We would take all those rebates and apply to our bottom line.

CM McGuire-Can you offer the same quality of play? Ans: Jeff Yost-Our main operations is as a golf course maintenance company, we have seen rounds and revenue go up and we have decided to go do that at other facilities. CM McGuire-What type of track record do you currently have? Ans: Jeff Yost-We have been around since 1989 (for golf courses). We have 3 branches of Down to Earth-a construction and irrigation company, a landscaping maintenance company, and a golf course maintenance company. We are in the middle of growing. Our corporate office is an hour and half from here. We are local.

CM McGuire-You want to take over this course and manage it for the City of Palm Coast as a lease option? Ans:Jeff Yost-Yes.

CM McGuire-You would provide same amenities as now? Ans: Jeff Yost-We believe the conditions at the course will dramatically increase. That is our bread and butter. Not much of a difference between these companies, the difference is in the philosophies. Our philosophy is for the tax payers not to pay for a golf course.

CM McGuire-Conditions includes the business as a whole? Ans: Jeff Yost-Absolutely, our goal is to make money. We do not want the tax payers to lose money. We are in it to make money. We will not run it into the ground.

VM DeLorenzo-Your proposal is the most intriguing, so much so that I met with staff. Do you lease one course? Ans:Jeff Yost-Yes for the past 6 months of a semi private looking to go private.

VM DeLorenzo-Cost to all the players if you miss your projections? Ans: Jeff Yost-Our proposal was that we would keep the rates the same. We proposed a 15% discount of the current rate for your residents to play.

VM DeLorenzo-Type of course you currently lease-semi private to private, marketing? Ans: Jeff Yost-We still market that course, we still have public play. The Club wants to go private.

VM DeLorenzo-Does the club you currently lease have a club house, restaurant? Ans: Jeff Yost-We do, we manage it, there is a contract with someone and he will run it til the end.

Mayor Netts-You stated if the course conditions deteriorates, you take a loss, but that is an asset that belongs to the City, wouldn't the City take a loss also as it is a City asset? Ans: Jeff Yost-We are not going to drive it into the ground, we will take care of your asset. It is important to us to take care of your asset.

Mayor Netts-What would the lease look like? What amount would the lease be? Ans:Jeff Yost-We would not charge anything and we would return the revenue sharing with you.

Mayor Netts-You have the operation of the course in your hands and the trends continue, what happens? Ans: Jeff Yost-We lose money, not the City.

CM McGuire-Are you a publically held company? Ans:Jeff Yost-Yes, we are.

VM DeLorenzo-How the rankings started one way but finished in another, please explain? Ans: Ms. Santangelo-We looked at those we wanted to bring in for

presentations and interviews. From there the presentation, interview and site visits determined the final rankings.

#### Public Comments:

Celia Pugliese-supports the golf course. The golf course is an asset to our community. Would appreciate whoever wins the contract to make sure it stays in great condition.

Mike Jackson-regular golfer at Palm Harbor. Supports Kemper Sports.

Tom Martone-provided pictures of the golf course, which is attached to the minutes. Lake on Fairway 13 is polluted and the dead fish in the lake smell.

Cathy Sarirish-supports Kemper for tennis. What plans do you have for the tennis center?

Matt Dunn, TDC-We have been soliciting our golf and tennis here in the County.

Richard Munsterman-Supports Kemper and Canfields. Isn't golf part of what Palm Coast has been soliciting?

Bob Otley-Marketing will not save golf in Palm Coast; most of us in Palm Coast are here for golf, tennis, or the beach. This is a reality not a marketing issue.

Revis Smith-supports Kemper Sports and their commitment to their golfers.

Carol Ogden-Tennis is also affected. Supports Kemper Sports. What is the plan for the Tennis Center?

Agnes Lightfoot-Friends of Tennis-Supports Kemper Sports.

Jack Carrall-Doesn't like the increase coming out of the general fund to support the golf course and tennis center.

David Tiernan-lives at the 3rd hole: supports Kemper

Jeff Davis-supports Kemper for tennis.

David White, Casper-Our firm is focused on those in this room. The course is not marketable in the condition it is in right now. We are proposing a small profit.

Jeff Yost, Down to Earth-I will promise you will not pay a dime in the next 3 years based on increasing the playability of the golf course.

Ben Blake, Kemper Sports-We are sincere in managing the golf course and ask that we be considered. Please continue this process and do more research. We appreciate the process and the opportunity to speak.

#### Responses to Public Comments:

Mayor Netts-There is a proposal to go from 38K to 42K rounds of golf-what is the nature of that proposal? Ans: Mr. Landon-Basically, the process is that each interested in running/leasing our golf course submitted a written proposal. They all made projections on rounds and revenues. Direct answer that you heard is we have experienced 38K rounds of golf per year and Billy Casper, who put out the 42K, said they believe over the next 2 or 3 years they can increase that number to over 40K rounds. Rounds equal revenue, which means they are saying they can increase the

revenue.

Mayor Netts-Is there a money back guarantee? Ans: Mr. Landon-Absolutely not.

CM McGuire-Would like to see the contract be a 2 or 3 year contract with a clause to get out of the contract.

Mayor Netts would like to see a committee of City employees and golf course management employees meet monthly to inspect the course and address issues before they become issues. Tennis courts management concerns him.
