CM DeLorenzo-The Villages Construction Co., have we ever selected them before? Ans: Ms. Kronenberg-No, we haven't. Mr. Peel-The Villages were pre-qualified and we have confidence in them. They have the licensure and believe they are a competent contractor.

CM Nobile-How much of this land (on the slides) is wetland on the east side of US1? Ans: Mr. Peel-Where we are discharging it? Ans: CM Nobile-Yes. Ans: Mr. Peel-It is a little hard to see on the aerial but it is probably something that looks like about that (Mr. Peel drew on the projection the area). Ans: Mr. Landon-I am not a wetlands expert but basically everything you see up there in light grey is wetlands. That whole area is wetlands.

Waste-Ans: Mr. Adams-There are two by-products of the wastewater treatment process. The effluent that is mostly reused and the solids are dewatered. The water goes back to the head of the plant. The solids get hauled off by a contractor, who takes it to central Florida to be further treated and is then turned into fertilizer.
