## **D.** Public Participation

## E. Discussion by CITY COUNCIL OF MATTERS NOT ON THE AGENDA

CM Cuff-The email relating to HB 17 repeal of Home Rule. Not sure what the legislators were thinking with this one.

CM Shipley-Happy Birthday to VM Nobile.

Mayor Holland-I concur with CM Cuff about this legislation. Attorney Reischmann read some of the language from HB 17.

Mayor Holland-Toured our hospital and met with Dr. Jimenez. Our local representative Renner filed a bill that will affect our local hopsital negatively. What Representative Renner fails to recognize is that 60% of our residents are on Medicare. It will have a direct negative impact on our hopsital and our residents. We need to support our hopsital. The bill provides for recovery centers which are operated under different measures than a hospital. It will have an impact on our local job economy.

CM Cuff-What is the bill number? Ans: Mayor Holland-It will take me a little time to review. CM Cuff requested the attorney send that legal citation to Council.

VM Nobile would like to read the bill and then make a decision to support or not.

## F. Discussion by CITY ATTORNEY OF MATTERS NOT ON THE AGENDA

Legislation relating to pre-emption, one of our legislators is our own Representative Renner. He is a co-sponsor to the pre-emption (home rule) I spoke of earlier.

## G. Discussion by CITY MANAGER OF MATTERS NOT ON THE AGENDA

*Mr.* Landon-Legislation proposals-It is amazing some of the bills coming through. Some of them get a lot of publicity like the bill to end "Visit Florida" and some other legislation that cuts back on helping support tourism and incentives for bringing businesses to Florida. At a local level, those bills are a real concern to us. For example, there is one proposal out there to cut funding to small business development centers, which is our partner with BAC. For us, small business is really our base, our bread and butter. It has been a very successful partnership. I think sometimes the people in Tallahassee do not realize the impact that has back home. Another bill is proposed, again by our Representative, not sure if it has been filed but there has been some talk every year on eliminating the business tax receipt. That does a couple of things. It hurts us financially. In order to maintain our level of service, the same revenue stream, what you would do is shift those dollars from businesses to our residents and that to me does not make sense whatsoever. More importantly than the dollars is that there is one person who investigates the scams, that business may try to take advantage of people, in particular the elderly, or the people that are taken advantage of by illegal contractors. It is those business tax receipt records that actually help us. It is those laws that allow us to stop them from doing business if they do not follow the local laws. It is important to us from that regulatory standpoint of protecting our citizens. We have seen many examples, where we have contractors say pay me in full before I get started and then they disappear. It is those types of regulations that help protect our citizens, so I do not think the people in Tallahassee understand the consequences.

Mayor Holland did have a conversation with Representative Renner yesterday, I did make him aware of that impact; our BAC as well as the discussion of the Business Tax Receipt. I know he will be discussing that with Beau Falgout. He indicated that if there was something within those portions of the bill, that he would be willing to look at it, address it, and take it out.

Mr. Landon-Legislative priorities still moving forward on our funding.

VM Nobile-Brush fires? Ans: Chief Beadle-We are ok right now.
