VM Nobile-Are there any homes that have applied but are not in this project? Ans: Mr. Papa-Yes, but due to the amount of funds we have available they were not funded. So if still needed they would have to apply next year. We do not have a waiting list.

VM Nobile-Are we expecting any more applicants due to Matthew? Ans: Mr. Papa-There are other sources for Matthew. Since this is the first in, first out program, there are of course, if they qualify through income, they are allowed to apply for the program.

VM Nobile-So this coming year we are looking at spending half of these CDBG dollars on the Seminole trail? Ans: Mr. Papa-That is correct.

VM Nobile-Have we already approved that? Ans: Mr. Landon-Yes, we have. Mr. Papa-We also have the SHIP program which has funds available for home repair and emergency assistance.

VM Nobile-Can we get any money from the TPO for the trail? Ans: Mr. Papa-Yes, we did get money for a portion of the trail.

VM Nobile-Will we be finished with this trail this year? Ans: Mr. Papa-Yes, we will be.

Mr. Landon provided a brief overview to the trails with funding from the TPO.

8 <u>16-487</u> RESOLUTION 2016-XX APPROVING THE ANALYSIS OF IMPEDIMENTS TO FAIR HOUSING

Mr. Landon provided a brief overview to this item. *Mr.* Papa introduced Ms. Margo Moehring of Northeast Florida Regional Council (NEFRC). Ms. Moehring provided a PowerPoint presentation, which is attached to these minutes.

VM Nobile-When you say a high percentage of home ownership, every home is owned, what do you mean by that? Ans: Ms. Moehring-Owner occupied.

VM Nobile-So the ethnicity is tied to their financial status also? Ans: Ms. Moehring-We did not make similar findings specific to their income level and again it did not relate to where they lived, we did not find "pockets." We simply found only ethnicity, there is a difference in impact.

CM Klufas-The 50% mark, where you spend 50% of your income on housing, does someone qualify into that group whether or not I make a \$1,000 per month and pay \$500 towards a house or I make \$20K and pay \$10K on the mortgage, is there a differentiation there? Or do they both fall under the same umbrella? Ans: Mr. Papa-It is mainly a monthly calculation.

VM Nobile-So you could be making a lot of money and just choose to spend a lot of money on housing and you are considered a problem, but it is not. It is for those who are making smaller amounts of money.

Mayor Holland-Palm Coast is more unique than many other communities because we have a high percentage of ownership compared to other communities, which is very rare. We are a newer community with newer homes rather than look at different sections of our community when HUD does that analysis, the findings that you then draw out of that and when you make recommendations as to address some of the issues of the findings, it is not one size fits all for housing, so do you take all that into consideration? I say that because having served on the NEFRC for over 6 years, Flagler County is different unto 6 other counties. We are the main population base, we have very different history, if you will, as far as ITT developing a certain kind of master plan development. I think it is an important distinction, we are a very unique distinct community, we are not going to be able to solve issues in the same way others do, we have to look at this comprehensively and long term and slowly.

Ans: Ms. Moehring-I agree and that is you are defining the importance of the local knowledge. The methodology may be the same for every single community but until you apply that local knowledge, that is when you know what it means and what you need to work on.

CM Cuff-Does our Land Development Code require 3 bedrooms? Ans: Mr. Papa-No. Mr. Landon-No, it is based on a minimum square footage of 1,200 sq. ft.

VM Nobile-What we are talking about here as a City, is not starter homes, senior living but making, enabling that because we are not putting up this stuff? So if somebody does not build it, ok, I do not know where are we being seen as being over-regulated. What is our role here? Ans: Mr. Landon-This is not attempting to talk about the regulations, this is attempting to take a look at a snapshot of what Palm Coast looks like and say do we want to go this way in the future or a little different way in the future. What we are hearing here is that we have an abundance of single family 1/4 acre lots. A good example is action you took tonight in the L Section. That was still a single family home but it doesn't have as large of a lot and doesn't have as much upkeep. We have others, Hidden Lakes and a variety of others that are happening in town. So that is a good example of things changing.

Mayor Holland-Do we have to submit a plan to HUD? Ans: Mr. Landon-This does not require Council to take action other than adopting this. This is an awareness document, let's take a look at ourselves process. Get input from the community-your advisory committee. The idea is then you take this kind of analysis, and when you do your five-year strategic plan for CDBG dollars, you take this into consideration. It is that five-year action plan and one-year action plan that really is the implementation document. This is more just take a look. There is nothing in here that requires Council to do anything.

	CM Shipley-I thought we did not receive any bids for this? Ans: Mr. Landon-We went out to bid, under formal bid and did not receive any bids, so we then went and contacted commercial pool contractors throughout our network and received 4

quotes-same basic concept of soliciting quotes. All Seasons Pools, which is a nationally recognized company came in with the low price at \$136,000. Our budget was \$175,000.

CM Klufas-Why were they so much lower? Ans: Mr. Landon-Age old question. The fact that we had nobody bid on this, tells me they are busy. When they are busy, you get higher bids. Staff is very comfortable with this firm. This is a commercial pool company that meets the criteria for the pumps, etc. We have no reason to believe there is a problem with the low bid.
