>If any person decides to appeal a decision made by the Planning and Land Development Regulation Board with respect to any matter considered at such meeting or hearing, he/she may want a record of the proceedings, including all testimony and evidence upon which the appeal is to be based. To that end, such person will want to ensure that a verbatim record of the proceedings is made.

## 1 REVIEW OF CHAPTER 9 - ENGINEERING DESIGN & UTILITIES

*Mr.* Ray Tyner, Planning Mangaer, introduced the background behind the Chapter 9 revisions and introduced Mr. Mike Peel, Engineer, and Mr. Bill Hoover, Senior Planner who gave a presenation which is attached to these minutes.

*Mr.* Hoover addressed the PLDRB members regarding the platting section of Chapter 9, involving flag lots, which staff recommends not changing this section of Chapter 9 although FCARD recommended changes to the flag lot section. Mr. Hoover gave some examples of issues with flag lots via his presentation.

*Mr.* Tyner addressed the PLDRB members regarding the history within the City of flag lots, and discussion ensued with regard to flag lots today clarifying that they are only allowed, per the code, within a Master Planned Development (MPD).
