#### 2 CITY MAINTENANCE OF POND AND LAKE BANKS UPDATE

Discussion of previous motion / recommendation made by the BEAC members to limit the mowing of the edge of City ponds ensued. Ms. Dawson gave an update after discussion with the City's Public Works Division regarding mowing procedures.

#### 3 TOWN CENTER CENTRAL PARK SCULPTURE GARDEN UPDATE

Ms. Dawson gave an update on the status of the Town Center Sculpture Garden, staff was awaiting the engineering drawings to be submitted. Ms. Dawson indicated that the drawings were submitted last week and next steps would be to review the plans with public works. Ms. Dawson also gave an update on the materials that would be used for the base of the sculpture (i.e.concrete). It is estimated by Ms. Dawson that one of the sculptures would be installed sometime during the second quarter FY'2019. The rest of the sculptures would be installed as phase II of Central Park proceeds.

#### 5 CITY POLICY FOR REVIEW OF UNDEVELOPED PROPERTY

Ms. Dawson provided a link to the City of Palm Coast zoning map. Discussion ensued of Flagler County's sale of property to Flagler Hospital.

Ms. Dawson was asked by the BEAC members what the process is for land being donated from a developer to the City, such as in the case of the Palm Coast Park DRI, which is proported to be donating some land to the City for a park. Ms. Dawson indicated that she would have to review with City Staff and have the appropriate person address this question for the BEAC members.

Mr. Seib asked for clarification on the annexation process that the City uses and Ms. Dawson will provide more information at a future BEAC meeting.

#### 6 SAWMILL CREEK PALM COAST PARK DEVELOPMENT HULETT BRANCH BUFFER

Chair Seib questioned what could be done when a property owner impacts the landscape buffer as though it is part of their personal property (clearing the buffer down to the water line). Ms. Myers explained that the City's Code Enforcement Division staff are not allowed to go onto someone's property to verify if the homeowner is clearing the buffer. They could only intervene if a complaint is filed regarding that situation. Ms. Myers relayed a story of one home owner who had cleared mangroves from City owned property and was required to pay to mitigate the situation.

#### 7 ENVIRONMENTAL REVIEW PROCESS EDUCATION

Ms. Myers addressed some questions raised by BEAC member Ms. Foltz. Discussioned ensued among the BEAC members and staff regarding the process of site development for the lands within the Palm Coast Park DRI. Ms. Myers explained to the BEAC members the process used by QEP (Qualified Environmental Professionals) to rate wetlands as either optiminal, moderate or minimal.





The City is incredibly proud that Palm Coast City Hall, which opened in October 2015, was awarded LEED certification at the Silver level for design and construction that demonstrates high performance in sustainable site development, water savings, energy efficiency, materials selection and indoor environmental quality. Palm Coast's is the fifth City Hall in Florida to be LEED-certified.

The LEED (Leadership in Energy and Environmental Design) rating system, developed by the U.S. Green Building Council (USGBC), is the foremost program for buildings, homes and communities that are designed, constructed, maintained and operated for improved environmental and human health performance.

The Community Rating System is administered under the National Flood Insurance Program and provides incentives for communities to join. By implementing higher standards and regulations, a community can earn points in the CRS and these points translate into flood insurance premium reductions for the citizens. The City of Palm Coast earned its Class 4 Designation in May 2017 and joined only 12 other communities in the nation which are a Class 4 or better. This Class 4 Designation translates into a 30% discount for policy holders in the Special Flood Hazard Area and a 10% discount for policy holders who are outside the Special Flood Hazard Area.
