# 2 APPROVAL OF THE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FEDERAL FISCAL YEAR (FFY) 2019 (FY 2019/20) ANNUAL ACTION PLAN

*Mr.* Jose Papa, Senior Planner, gave a presentation which is attached to these minutes.

*Mr.* Scully discussed a prior recommendation regarding the "mini grant" program that was previously discussed, he recommended that the CATF members vote to get the "mini grant" program written, in place and advertisd. Further discussion ensued about the process for writting the grant requests for the public service subrecipient assistance funds.

*Mr.* Papa clarified for the CATF members what the next steps would be to get a "mini grant" program in place. The steps required would be to provide for the mechanism to accept grants, to score grants and to monitor grants. These items would be created by someone who has created a similiar program, typically the City would rely on it's grant administrator (a consultant) to help the City setup these programs. Including the paperwork and establising what subreceipient need to met and receive the grant. Once this process is complete, advertizing would be the next step.

*Mr.* Papa clarified the time frame and cost associated with working with a consultant to document the process and procedure for a new "mini grant" program.

Discussion ensued about increasing the planning, administration and monitoring allocation within the plan to \$10,000, with a strong recommendation for the board to initiate a plan to get the public services money out (to the potential recipients).

*Mr.* Papa clarified the role of a consultant "ranking" of grants along wneed to avoid any conflict of interest in the awarding of any grants.

The committee members discussed alternative methods that the city council has used to award GDBG funds other than a grant program. Mr. Papa clarified the rules for the recipient to qualify for a GDBG award.

#### Pass

Motion made to approve as amended to accept the annual action plan with an adjustment to increase the planning and administration, based on the thumbnail estimate to \$10,000 in order to account for the additional consulting work that would be necessary to properly implement a mini grant program, which this board strongly recommends made by Board Member Scully and seconded by Board Member Dodson-Lucas
