2 ELECTION OF A VICE CHAIR TO THE BEAUTIFICATION AND ENVIRONMENTAL ADVISORY COMMITTEE

3 THE MONARCH BUTTERFLY UPDATE

Chair Seib gave a brief background on this agenda item, including his efforts to get an update from the Palm Coast Garden Club. Chair Seib introduced Mr. P.M. Reddy and he gave an update on his experience creating butterfly gardens. He also gave a handout of a sketch of a proposed butterfly garden, which is attached to these minutes. Mr. Reddy suggested the cost of the butterfly garden to be added to the rain garden located at City Hall would be approximately \$1090.00. Mr. Reddy also suggested the City look into creating a botanical garden. Chair Seib asked if the City would consider supporting the cost of the Monarch garden. Ms. Dawson indicated that if the BEAC members voted in support of the Monarch garden at the discussed location than Ms. Dawson would have to take the proposal to the Parks Team to discuss funding. Mr. Reddy mentioned that there is a Florida Wildflower Foundation that may grant up to \$3000.00 for this project. Mr. Partelow suggested that the BEAC reach out to Palm Coast Garden Club about supplying some the required plants for the garden. Ms. Dawson also addressed the need for community involvement in maintenance of the garden.

E NEW BUSINESS

5 NUTRIENT POLLUTION OF FRESHWATER CANALS IN PALM COAST

Chair Seib introduced this agenda item and gave a PowerPoint presentation which is attached to these minutes.

Chair Seib asked if the airboats used in dislodging any aelgae growth are owned by the City. Ms. Denise Bevan, City Administrative Coordinator, answered that work is contracted out.

Chair Seib asked Ms. Bevan if the City had a program to clear natural ferns from the waters' edge. Ms. Bevan explained the process for maintaining the City's stormwater system, which include the fresh water and salt water canal systems, ditches (both major and minor) and swales system.

Chair Seib asked if there is a specific measurement used for the easement between a property and the waters' edge. Ms. Dawson did not know but said she would follow up with the City's Stormwater Division.

Discussion ensued between the BEAC members regarding recommending a regulation from the property line (a know element) to the waters' edge (an unknown element) to limit nutrient pollution of the waterways.

Ms. Bevan discussed the background retional behind the City's Stormwater's Division discussion of using dredging.

Ms. Bevan to follow up with the City's Stormwater Division and Public Works regarding the maintenance program currently in use by the City and will discuss at the next BEAC meeting on February 27th.

Chair Seib opened this item to public comment at 6:17PM.

Mr. Paul Pritchard, 10 Craft Court, addressed the BEAC members and is in favor of this agenda item and recommended that the BEAC expand their research to include salt water canals.

Chair Seib closed this item to public comment at 6:32PM.

Chair Seib agreed to expand this project to include review of the City's salt water canals.

6 DISCUSSION OF VINNIE THE VAN GOGH TURTLE DONATION AND FUTURE GOLF PROPOSAL

Chair Seib requested that this item (agenda #6 be heard prior to agenda items #2-#5) since no objection was made this agenda item was heard out of order.

Ms. Nancy Crouch, Palm Coast Arts Association, was introduced by Chair Seib, and she gave a presentation which is attached to these minutes.

Mr. Beier questioned who pays for the turtles. Ms. Crouch explained that the sponsor pays for all turtle related expenses, which is \$5,000.00. Mr. Beier questioned is there a plan to maintain the turtles. Ms. Crouch explained they would only need a clear coat. Mr. Beier questioned how many turtles are planned and who determines the theme of the turtles. Ms. Crouch explained that the sponsor determines the theme and she hopes eventually there would be 50 turtles throughout the City of Palm Coast.

Mr. Knapp questioned the percentage that actually covers the expenses for the Turtles. Ms. Crouch indicated that 60% is for the actual expenses and the remainder (40%) goes to the Palm Coast Art Association fund raising goals.

Ms. Bevan updated the BEAC members regarding the guidance given to the Planning Division from the City Council regarding the review of the Comprehensive Plan. She also gave some information on the County's PACE program which involves a credit on property taxes for installing solar power.

Discussion of recommendations to make to City staff involving the incentives in place for green building programs including education for the citizens about programs that are available. Chair Seib asked the members to come up with some ideas for the next BEAC meeting.

Saltwater Canal Facts

- 23 miles of saltwater canals in PC
- Most (or all) homes are built with bulkheads, so no city owned easement
- Canals are tidal, fed by Intercoastal Waterway








Saltwater Canal System










Canals and Intercoastal Waterway



Pollution Issues

- Same as in freshwater canals
- Sewerage, trash, organic matter, pesticides and fertilizers
- Streets drain into canals, gas, oil residue

Bulkheads deteriorating



Bulkheads deteriorating factors

- Soils from yards leeching into canals
- Soils contain both pesticides and fertilizers
- Ends up as a poisonous muck bed in canals





Saltwater canals with bulkheads issues

- Pollution loading of canals occurs as a result of shoreline development. Septic seepage, lawn fertilizers, pesticides and effluent, and oil and gasoline from boats negatively impact canal water quality.
- Paved parking lots and streets prevent land areas from absorbing polluted runoff, so pollution-laden rainwaters drain directly into canal systems.
- Inadequate flushing prevents the canal system from diluting and dispersing pollutants to the receiving waterbody. Contaminants may accumulate on the water surface or build up in the sediment.

Saltwater canals issues continued

- Most canals are virtually closed bodies of water that serve as nutrient traps, and the accumulation of decaying organic matter on the canal bottom impedes healthy biological production.
- Native wildlife, including benthic (bottom-dwelling) animals, fish, birds and mammals are frequently abundant in newly constructed canals.
- The advent of hot weather can result in increased temperatures and dramatic decreases in dissolved oxygen concentrations with heavy mortality of benthic organisms and fish resulting. In cooler weather, animals may recolonize as dissolved oxygen concentrations increase.

Grand Solutions? Or small positive steps ("one small step for a man...")

- Freshwater canals-require homes bordering canals to leave the last five to ten feet between rear property line and waters edge natural or clear the brush/native vegetation and plant an attractive waters edge plants not requiring fertilizers or mowing.
- Saltwater canals-divert street runoff from canals to retention ponds or some other location, require bulkheads to meet specifications, i.e. not be deteriorating or damaged
