2 PALM COAST STORAGE ON SR 100 TECHNICAL SITE PLAN - TIER 3, APPLICATION # 4011

Mr. Ray Tyner, Deputy Chief Development Officer, introduced this item along with *Mr.* Bill Hoover, Senior Planner, who gave a presentation which is attached to these minutes.

The applicant's representative, John Abi-Aoun PE, VP of Florida Engineering Group, gave a presentation which is attached to these minutes.

Mr. DeMaria questioned the hours of operation for this facility. *Mr.* Mike Stewart, developer's representative, clarified the hours of operation would be from 9AM-5PM, 7 days per week, and access via pass to the facility by unit renters from 6AM-midnight is proposed. Mr. Stewart also clarified for the Board Members that no work on vehicles would be allowed on their premises.

Acting Chair Smith opened this item to public comment at 5:50PM and no one indicated via method identified at beginning of meeting any interest in speaking and therefore Acting Chair Smith closed this item to public comment at 5:51PM.

3 SPRING LAKE AT PALM COAST PARK SUBDIVISION MASTER PLAN - TIER 2, APPLICATION # 4253

Acting Chair Smith declared a conflict and recused himself from participating in any discussion about this item as well as voting on this item. He filed the required form 8B with the recording secretary.

Mr. Ray Tyner introduced this item including its history with being a part of the Palm Coast Park Development of Regional Impact (DRI) and Master Planned Development (MPD). He also introduced Mr. Bill Hoover, who gave a presentation which is attached to these minutes.

Mr. DeMaria asked if there were any plans for sidewalks on both sides of this project. *Mr.* Ken Belshe, representative for the developer indicated yes sidewalks on both sides of street are planned. *Mr.* DeMaria asked if the property would be a gated community, age restricted, and what is the price range on the homes. *Mr.* Belshe stated that the project will not be age restricted, it will be gated, however the gate will be a "soft" gate due to Community Development District (CDD) monies being used for the infrastructure, and the pricing of homes would be in the \$300,000 to \$450,000 range.

Mr. DeMaria inquired about the buffers being used to shield the property from the major roads of RT. 95 and US 1. *Mr.* Belshe clarified that the property is quite a distrance west of RT 95, so he addressed this question as it pertains to the buffers along US 1 indicating that there will be landscapping along the far eastside of the property that will buffer the road noise.

Mr. Dave Freeman asked about whether or not the roads will be public or private as it relates to school buses coming into the neighborhood. *Mr.* Belshe answered that the roads would be owned by the CDD and therefore would be public however accomdations would be made to allow access for the school buses.

Acting Chair Smith opened this item to public comment at 6:06PM and no one indicated via method identified at beginning of meeting any interest in speaking and therefore Acting Chair Smith closed this item to public comment at 6:07PM.
