D STAFF BUSINESS MEETING ITEMS

2 WORKSHOP GREEN BUILDING INCENTIVE PROGRAM

Chair Seib had previously distributed a revised "A Community Responds to Climate Change" document which differs from the version in the agenda in the introduction, background and conclusion sections only. Chair Seib also presented a PowerPoint on this topic, both the revised document and the PowerPoint are attached to this record.

Ms. Jordan Myers, read comments from Mr. Ray Tyner, Deputy Chief Development Officer, referencing the proposed program his comments start with the section Building & Development - Element #1 - Mr. Tyner suggests removing the statement that LEED certification would apply to retrofitting of residential properties. He suggests that the LEED certificaiton should be left for businesses and commercial properties only since residential homes are better served under the existing Green Building Incentive Program with their \$10,000 Building Division budget, Mr. Tyner's comment also clarified that the City cannot waive permit fees due to state statute however they may be reimbursed. Ms. Myers also commented that this incentive item would be scheduled for the January 19, 2022 Planning and Land Development Regulations Board (PLDRB) meeting.

Mr. Partelow questioned the available existing Green Building Incentive of \$10,000.00 being sufficient. Ms. Myers commented that currently the funds are not being utilitzed by the single family home builders and by now allowing these funds to be only used for residential single family or duplex homes the funds will go farther. Also through the launch of the new business/commercial incentives we may be able to relaunch the program for residential homes as well.

Mr. Knapp asked if anyone contacted FP&L regarding the increased demand for electric needs as we promote electric charging stations for electric cars. He referenced his experiences with rolling blackouts in California. Discussion ensued between the BEAC members regarding various energy sources (i.e. nuclear energy).

Mr. Dillion Long, student at Flagler Palm Coast High School, who has been participating in the BEAC meetings regarding the addition of electric car charging stations, was asked by Chair Seib to comment on the proposal being discussed and he stated that thus far he didn't have any comments. Chair Seib stated that changes to the proposed Green Building Incentive Program January 19th PLDRB meeting presentation would be shared via City staff to the BEAC members and staff will include Mr. Long for his comments on electric vehicle charging stations proposals.

Chair Seib also presented a PowerPoint which is attached to this record. BEAC members discussed proposed changes to the PowerPoint presentation based on *Mr.* Tyner's feedback.
