#### A CALL TO ORDER

Mayor Alfin called the meeting to order at 9:00 AM

#### C ROLL CALL

*City Clerk Virginia Smith called the roll. All members were present. Vice Mayor Branquinho was in attendance remotely due to extenuating circumstances. Council voted unanimously to allow Vice Mayor Branquinho to appear, participate, and vote remotely in today's meetings.* 

#### D PUBLIC PARTICIPATION

Public Participation shall be held in accordance with Section 286.0114 Florida Statutes. And pursuant to the City Council's Meeting Policies and Procedures:

(1) Each speaker shall at the podium, provide their name and may speak for up to 3 minutes.

(2) The Public may provide comments to the City Council relative to matters not on the

agenda at the times indicated in this Agenda. Following any comments from the public, there may be discussion by the City Council.

(3) When addressing the City Council on specific, enumerated Agenda items, speakers shall:(a) direct all comments to the Mayor;

(b) make their comments concise and to the point;

(c) not speak more than once on the same subject;

(d) not, by speech or otherwise, delay or interrupt the proceedings or the peace of the City Council;

(e) obey the orders of the Mayor or the City Council; and

(f) not make any irrelevant, impertinent or slanderous comments while addressing the City Council; which pursuant to Council rules, shall be considered disorderly.

(4) Any person who becomes disorderly or who fails to confine his or her comments to the identified subject or business, shall be cautioned by the Mayor and thereafter must conclude his or her remarks on the subject within the remaining designated time limit.

Any speaker failing to comply, as cautioned, shall be barred from making any additional comments during the meeting and may be removed, as necessary, for the remainder of the meeting.

Members of the public may make comments during the public comment portion of the meeting. Please be advised that public comment will only be permitted during the public comment portions of the agenda at the times indicated by the Chair during the meeting.

Robert MacDonald stated that he is looking forward to a civil unity on Council as we head into 2022.

Dan Bryant addressed the safety on Cimmaron Drive. Mr. Bryant shared that over the last few weeks he has noticed an increase in traffic, construction, and more pedestrians. Additionally, Mr. Bryant shared about the section of road that he is most concerned about in the area.
