## 4 UPDATE ON MONARCH CITY USA MEMBERSHIP

Jordan Myers, Environmental Planning Technician, gave an update to refresh the members on standards as to become a Monarch City from a previous BEAC meeting.

Ms. Mackler suggested planting milkweed by the turtle sculptures. Ms. Myers suggested that the milkweed planting may be more appropriate at the City owned turtle properties and that she would discuss this option with the City Parks' Team. She also mentioned that any signage would need to be included in the presentation with the Parks' Team and should be cohesive with existing turtle signage. Ms. Myers suggested revamping the existing butterfly garden at Linear Park as a trial site to see how the program works out.

Chair Seib discussed a prior presentation by City Staff regarding the sea walls as it relates to maintenance and intercoastal pollutants. It was discussed the possibility of this item being added to the next agenda.

Chair Seib asked the BEAC members to bring in suggestions for topics future BEAC meetings and to bring them to the next meeting for discussion.

Chair Seib also offered a suggestion of looking at the City owned properties for beautification opportunities. Ms. Myers stated that when looking at those parcels we need to keep in mind if they are used for stormwater purposes.
