Background :

UPDATED BACKGROUND TO THE APRIL 19, 2022 BUSINESS MEETING.

This item was heard by City Council at the April 19, 2022 Business Meeting. City Council requested the opportunity to interview the applicants at a workshop prior to appointing an applicant to the committee. All background checks have been completed and are available in Human Resources.

Mr. Doak is unable to attend due to a previous commitment and has submitted a letter of interest to City Council, which is attached to this item.

ORGINAL BACKGROUND FROM THE APRIL 19, 2022 BUSINESS MEETING.

The City of Palm Coast's Beautification and Environmental Advisory Committee was created under Resolution 2006-07.

Section 2.(b). The Committee shall be constituted of a total of five (5) voting members with one (1) member being appointed by the Mayor and each member of City Council from the City Council district represented, if practicable. All Committee members must be registered voters and residents of the City of Palm Coast. Each member shall serve terms of four (4) years, but the City Council may develop a program of uniform appointment and reappointment for all appointed bodies providing for uniform appointment dates, staggered terms and related matters.

Section 2.(c). The objectives of the Committee shall be to identify issues within the City of Palm Coast relating to the beautification, scenic beauty, natural resource conservation, aesthetic enhancements, environmental protection and other related matters and to evaluate and consider activities, methods, projects and programs that could be implemented within the City to address the matters considered by the Committee and the issues studied by the Committee. The Committee may make recommendations to the Planning and Land Development Regulation Board with regard to Comprehensive Plan amendments and land development regulations involving its areas of review.

The term for the five members of the Beautification and Environmental Advisory Committee (BEAC) expire on May 1, 2022. The regular members of the committee are: Mr. Robert Knapp, Mr. Edward Beier, Mr. Glenn Partelow, Ms. Robbyn Mackler, and Mr. Jeffrey Seib.

Staff advertised in various ways on multiple occasions, including reaching out to the past Citizen's Academy graduates, advertising in the media, on social media sites, as well as the City's website.

District information has been verified by the City Clerk's office. Staff has performed the necessary background screening.

The Mayor and City Council will each appoint one member to the Committee.

Background :

The translation to Spanish is required per state law.

The City Clerk is requesting Council's consideration in allowing the "Statement of Ethical Campaign" be distributed to all City Council candidates, in the candidate handbook.

Subject PRESENTATION - PAVEMENT MANAGEMENT PROGRAM UPDATE

Background :

PRIORITY:

F. Street Maintenance

1) Develop alternative options to traditional funding sources to ensure funding of streets maintenance program for striping and resurfacing by providing a projection of road maintenance currently budgeted vs. needs for future years

2) As part of street resurfacing and maintenance program, investigate and where feasible, apply the following.

- Intersection safety improvements shall be conducted to address turn radius conflicts
- Enhancements to support the use of autonomous vehicles
- Traffic calming alternatives
- Continue the incorporation of innovative assessment methods

As noted above, maintaining a quality system and spending the City's maintenance funding judiciously is at the forefront of the adopted City Council Priorities.

In order to be more efficient with the limited funding available and ongoing needs (1,126 lane miles), the City sought professional engineering services for the implementation of a pavement management program. This program is designed to preserve and extend the useful life of paved surfaces throughout the City and optimize the available funds to meet the network condition needs. With careful planning and diligent effort, highest performance standards are maintained while reducing the overall long-term costs of managing the network pavement system.

On August 1, 2017, City Council approved a contract with Transmap Corporation to assist in the development of a Network Pavement Management System. The general objective was for the consultant to collect pavement data by way of a digital survey and to create a Pavement Condition Index (PCI) for each city maintained roadway. The PCI allows the City to determine a pavement condition standard and plan for maintaining all roadways.

Given the persistent shortage of funds for maintaining these street systems, the preservation and stewardship of existing roads have become major activities for all levels of government. An excellent way of maximizing the return on investment for the money that exists for road maintenance is to implement a Pavement Management System. Pavement management is a systematic approach to extending the life of a pavement network. More specifically, it is the process of planning, budgeting, funding, designing, constructing, monitoring, evaluating, maintaining, and rehabilitating the pavement network to provide maximum benefits with available funds. A Pavement Management System provides tools and methods for finding and implementing the best Maintenance & Rehabilitation (M&R) strategies. Repairing streets when they are still in fair condition ultimately cost less over their lifetime than waiting to fix roads that have fallen into poor condition. In other words, the proactive approach of routine pavement management means less money wasted on frequent roadway reconstruction and a potential savings of millions of dollars.

On August 28, 2018, City Council was presented with the findings of the Final Pavement Management Report. Those findings determined time Arterial and Collector roadways had a PCI average of 83 and Local roadways had a PCI average of 78. In order to maintain the current level of service, existing PCI average, additional funding was and is still needed.

In order to provide a more accurate forecast and better performance model for roadway maintenance, it is recommended to have the roadways digitally surveyed every 4 to 5 years.

On August 17, 2021, City Council approved a Work Order with Transmap Corporation to conduct a survey and to provide a report and updated forecast for the city's pavement management program comparing project revenue as well as recommended funding needed to maintain the current roadway system condition for arterial and residential roads.

This item is a presentation to present City Council with the findings and funding need based upon the updated survey that was completed.

Background :

This item is a request to exceed the City's CDBG Cost Feasibility Limit in order to complete rehabilitation of a single-family home for an eligible applicant to the City's housing rehabilitation program.

Since 2012, the City of Palm Coast has offered an Owner-Occupied Housing Rehabilitation program using funds from the City's annual allocation from the Community Development Block Grant (CDBG) program.

The objectives of this program include, the following:

- To remove unhealthy or hazardous conditions in Very-Low Income (VLI) (50% less than Area Median Income) and Low-Moderate Income (LMI) households (51 to 80% of Area Median Income),
- To preserve existing housing stock or replacement of substandard housing,
- To enable VLI and LMI families to rehabilitate their homes by providing financial and technical assistance to those unable to obtain private financing.

A typical scope of work for homes receiving financial assistance have included: roof replacement, Heating, Ventilation, and Air-Conditioning (HVAC) systems, new doors and windows (for energy efficiency), and other rehabilitation work to address health and safety issues (mold remediation, electrical upgrades, etc.)

Other program rules are governed by the Local Housing Assistance Plan (LHAP). Based on the LHAP, Section VI(C) the maximum cost limit for a rehabilitation project is \$50,000. However, the limits may be exceeded when alternative funds are available but must be specifically approved by the City Manager.

The scope of service for a recent qualified applicant has shown the need for rehabilitation work that will exceed the program's cost feasibility limit. This home has significant roof damage that will require the replacement of the trusses as well as replacement of all shingles and sheathing. Additionally, due to the intrusion of moisture into the home it has become necessary to replace dry wall in the interior of the home along with the need for mold remediation.

The estimated cost for the scope of work is \$163,364. The estimated cost can be directly tied to the amount of repair necessary to address all the health and safety issues needed to bring the home into an appropriate level of livability, and also due to the unpredictable and volatile costs associated with construction in today's market (materials and labor).

City staff in partnership with the Administrators of the Flagler County SHIP program have agreed to commit funds to assist the homeowner to complete the rehabilitation work. The City-County have an Interlocal Agreement for the Joint Local Housing Assistance Program (LHAP) that, among other things, allows the City to coordinate with the County to implement Affordable/Workforce Housing programs by mutual consent.

City/County staff have discussed splitting the cost in half for a total contribution of \$81,682 from each program (CDBG and SHIP). Additionally, staff under conditions of the rehabilitation program will relocate the homeowner for a period of six (6) months while the rehabilitation work is completed. The relocation cost will be \$600/month or a total of \$3,000. The cost of temporary relocation will be borne by the CDBG program solely. This relocation as recommended by the City's Housing Rehabilitation Specialist is necessary to expedite and complete the work in the most time and cost efficient manner.

Staff is requesting the allocation of an additional \$34,682 (\$31,682 for rehabilitation and \$3,000 for temporary relocation) over the typical cost feasibility limits to complete the rehabilitation work. The remainder of the project cost \$81,682 will come from the Flagler County SHIP Program.

Background:

This item is for standard operations.

In 2004, the Fire Department began operating as a State of Florida Advanced Life Support (ALS) service in order to provide the best possible care to residents and visitors of the City. State statute requires ALS providers to carry certain equipment and a battery-powered portable cardiac monitor/defibrillator for each ALS Unit is a requirement.

The current stock of LifePak Cardiac Monitors are approaching end of serviceable life and technical support. The Palm Coast Fire Department provides non-transport advanced life support and transport to receiving facilities is provided by Flagler County Fire Rescue Medical Units and they both agencies currently use LifePak Cardiac Monitors from Stryker Medical. After comparative analysis of competing vendors and to ensure continuity of care, the City selected the same equipment based on functionality, price, and compatibility. This purchase includes trade-in credit, service agreement, and in service training and replaces the current cache of monitors that are approaching obsolescence. These ten units are to be purchased through American Rescue Plan Act (ARPA) funding and the total cost is under the originally budgeted amount of \$320,000. Stryker Medical has quoted the City under the anticipated expense to purchase the LifePaks Cardiac Monitors.
