Mayor Alfin called the meeting to order at 6:00 p.m.

C. ROLL CALL

City Clerk Virginia Smith called the roll. All members were presented. VM Branquinho appeared via zoom and is excused from voting on the items presented to Council this evening.

#### D. PUBLIC PARTICIPATION

Public Participation shall be held in accordance with Section 286.0114 Florida Statutes. And pursuant to the City Council's Meeting Policies and Procedures:

(1) Each speaker shall at the podium, provide their name and may speak for up to 3 minutes.

(2) The Public may provide comments to the City Council relative to matters not on the

agenda at the times indicated in this Agenda. Following any comments from the public, there may be discussion by the City Council.

(3) When addressing the City Council on specific, enumerated Agenda items, speakers shall:

(a) direct all comments to the Mayor;

(b) make their comments concise and to the point;

(c) not speak more than once on the same subject;

(d) not, by speech or otherwise, delay or interrupt the proceedings or the peace of the City Council;

(e) obey the orders of the Mayor or the City Council; and

(f) not make any irrelevant, impertinent or slanderous comments while addressing the City Council; which pursuant to Council rules, shall be considered disorderly.

(4) Any person who becomes disorderly or who fails to confine his or her comments to the identified subject or business, shall be cautioned by the Mayor and thereafter must conclude his or her remarks on the subject within the remaining designated time limit.

Any speaker failing to comply, as cautioned, shall be barred from making any additional comments during the meeting and may be removed, as necessary, for the remainder of the meeting.

Deborah Sines-was here previously asking for help with Cimmaron Drive issues. She must drive to walk her dog, speeding is a chronic problem, speeders coming out of the gated community, The Sanctuary. Consider us in the budget. I am putting you on notice if someone gets hurt, I will dust off my bar card.

George Mayo-concerned that the pavement lines in the roundabout and streets in Town Center are worn away. This is a safety issue. The lines need to be repainted.

Joe Runac, 7 Courtney Ct.-Friday night meeting of the proposed cell tower. 80-100 people in attendance; everyone agreed that the location is not good and is visible to all. Timing of the meeting was poor. Some neighbors did not receive notification from the cell tower company. Cell tower representatives made it seem like this was a done deal. They were told not to ask questions. The phrase 'I don't know' was uttered countless times by the cell tower attorney. His home is at 'ground zero' and in direct view. Extends an open invitation to the Mayor and Council to please come and see this from his point of view, regarding the view and the value of his home. Requesting that Council squash this, and not put the tower there.

Rhonda Stapleford-safety on Cimmaron. Has been run off the road walking and on bicycle. Very dangerous, construction trucks never yield. Children waiting for the bus are either in the road, or in the swale which is often filled with water. Would like a sidewalk on Cimmaron. Anna Maria Long, Executive Officer with the Flagler Homebuilders Association-Questions why an ACH/Bank transfer fee of 3.5% is assessed when paying permit inspection fees. Why is that fee charged and where does the money go?

Carmen Sousa-Cimmaron Drive. Likes to bike, but it is very dangerous on Cimmaron because of traffic, and drivers not respecting the speed limit. Is asking for the City of Palm Coast to think about what we need for the safety of our neighborhoods.

Corey Herod-Cimmaron Drive. Was drawn to Palm Coast for the extensive trails, parks, and paths, but soon realized that the last mile connecting his neighborhood to the infrastructure was missing. Traffic has increased because of the massive buildout of his neighborhood. Would like a sidewalk on Cimmaron, but also wants to Council to consider more immediate solutions such as pedestrian crosswalks and speed bumps.

Scott Korum, 27 Cleveland Ct- Cimmaron Drive. Wants to emphasize the safety issues for people in wheelchairs and walkers, and how dangerous for those residents.

Cathy Fining, Cimmaron Drive-my mailbox has been hit 4 times. Speeding is an ongoing issue. The Sheriff's office has been ineffective. You need to do something. Does not want a sidewalk.

Gwen Christiensen, Cimmaron Drive-thanked the Mayor and Council for trying to make Cimmaron Drive safer for all. Described the conditions of Cimmaron Drive in detail and asked that Council provide a timeline of the next steps.

*Mr.* Abdel El-Farghali-Safety on Cimmaron. Provided photographs of Cimmaron Drive, which are attached to these minutes.

Dan Christiensen-Cimmaron Drive safety. Described conditions on Cimmaron in detail.

Al Krier-Cimmaron Drive safety. Argued for the City to take action now to make the streets safer. Thanked the Mayor for always being available. Thanked all the residents for coming out tonight to speak.

William Fining-speeding is a problem. 30 mph is too fast. Give out tickets.

Steve Carr-speeding is a problem. Florida Park Dr is closed for maintenance, but it does not stop the speeding.

#### Responses to Public Comments:

CM Fanelli-when we speak of the children of our community and their safety, it hits close to home. I have children and we live off Cimmaron. I try to be very cognizant of my speed and of the people who are jogging, walking, and biking. In my role with the school district, as Principal, we lost a student at a bus stop. It strikes a chord. Would like the City to look for grant opportunities and asks that citizens look for grants to fund sidewalks for the safety of our citizens.
