#### Background:

The International Institute of Municipal Clerks (IIMC) and its partner, the Florida Association of City Clerks (FACC), are professional associations that promote continuing education and certification through university and college-based institutes. IIMC's primary goal is to actively promote the continuing education and professional development of municipal clerks through extensive education programs, certification, publications, networking across the globe, annual conferences and research. FACC's primary goal is to actively promote the continuing education and professional development of Municipal Clerks in the State of Florida by partnering with the Florida League of Cities and the Florida Institute of Government to meet the ever-changing educational needs of City and Town Clerks and Deputy Clerks and to improve their knowledge in areas such as public administration, law, management, elections, and many other disciplines.

Currently, only 30%, or 4387, of the 14,755 members of the International Institute of Municipal Clerks have attained the Certified Municipal Clerk designation. Of the 669 members of the Florida Association of City Clerks, only 64%, or 431 members, have reached the Certified Municipal Clerk (MMC) designation.

To achieve the Certified Municipal Clerk designation, a clerk must have completed the International Institute of Municipal Clerks approved Municipal Clerks Institute Program conducted by the John Scott Dailey Florida Institute of Government, Florida State University in Tallahassee. This program provides 120 student/instructor contact hours of in-depth courses in managerial and leadership skills, social and interpersonal concerns, and technical training needed to deal with changes taking place in government today.

Completion of a recognized career development academy or a baccalaureate degree in public administration or related field, responsible experience in local government, and participation in conferences, meetings, and educational seminars are required to earn the prestigious Certified Municipal Clerk designation. The program aids municipal clerks in improving job performance and recognizes the professionalism of the Municipal Clerk's office.

The pinning ceremony being held is for Kaley Cook, Deputy City Clerk, who received her Certified Municipal Clerk designation.

On September 21, 2021, City Council adopted Resolution 2021-130 adopting guidelines and procedures for the official naming of public facilities. The City has received a request to name a City-owned public facility.

#### The Al Krier Trail:

Council Member Theresa Pontieri is requesting to name the walking trail on Palm Harbor Parkway (from the point of Cimmaron to European Village) in honor of Mr. Al Krier. Mr. Krier was a well-respected advocate for the safety and walkability of Cimmaron Drive. Council Member Pontieri submitted an application to the City for review. Upon review and approval by staff, the application moved to the Beautification and Environmental Advisory Committee (BEAC) for review. The BEAC met on March 23, 2023, unanimously approved the nomination, and recommended the request be presented at City Council.

In addition to the recommendation of the Al Krier Trail, staff will present an update on Council Priority B3 regarding naming of a facility in honor of Mayor Jon Netts.

#### ORIGINAL BACKGROUND FROM THE APRIL 11, 2023, WORKSHOP:

**Council Priority:** 

C. Safe and Reliable Services

Since 2006, the City of Palm Coast has operated its own fiber network. This network has allowed the City to connect all its locations without the need to pay a private entity for connections at each individual site. This network has been foundational to the way the City operates. We are currently wrapping up an initiative of segregating the Water Utility onto its own isolated network for security purposes, which is made possible by the City's fiber network. The network enables us to remotely monitor and manage a majority of the traffic cabinets in the City, as well as handle the bandwidth from the City's 200+ security cameras.

Through our fiber network we can connect and partner with other local governments. Our connection to Flagler County enables us to share GIS information as well as share our camera feeds with the Flagler County Sherriff's Office. Flagler County Schools rely on our fiber network to keep all its locations connected. We are also exploring a partnership with Florida Department of Transportation (FDOT) to share traffic camera feeds with them that would be enabled through the fiber network.

A gap exists in the network on US 1 from Palm Coast Parkway to State Road (SR) 100 of about 35,000 feet. Filling this gap would increase the network's resiliency and protect against service disruption caused by a break in the fiber. This build has not been pursued in the past due to cost, which was estimated at \$1.5 million.

As part of their buildout in Palm Coast, Metronet will be installing fiber along US 1. Metronet has agreed to allow us to install conduit along with them, utilizing their contractor for a substantial cost savings to the City. Extending the City's fiber network from Palm Coast Parkway to SR 100 would complete a fiber ring which would allow for more reliable uptime of

the network. It also positions us to be able to add the Palm Coast Parkway, Whiteview Parkway, Royal Palms Parkway, and SR 100 traffic cabinets to our network in the future.

For this project, the installation of conduit, handholes, and ground rods must be sole sourced to Unified Utility Services LLC as this is a joint construction venture and these items are only available from this vendor. City staff electronically posted the Intent to Award for seven (7) business days in accordance with Section 287.057(3)(c) Florida Statutes as this item is greater than \$35,000. No other potential vendors responded.

City Council approval is required for contracts valued over \$50,000 in accordance with Chapter 2 Article 1, Division 3, Section 2-26A of the City Code. Therefore, based on the foregoing, City staff recommends that City Council approve purchasing the required services from Unified Utility Services LLC.

The City has an existing contract with Danella Companies, Inc., for outside plant construction and goods that will be utilized for the purchase of materials for the project, as well as fiber installation and splicing.

The FY 2023 budget includes \$178,125 for FiberNET capital. \$388,118 from FiberNET's reserves would need to be transferred over to complete this project.

#### C. Safe and Reliable Services

The Public Works Fleet and Facilities Management Division is seeking authorization to contract with Johnson Controls, Inc., to retrofit the Community Center's existing HVAC (heating, ventilation, and air conditioning) system from Trane to Metasys. This conversion will bring the building into the existing Metasys network, allowing remote visibility and control and the standardization of all Citywide systems.

We currently piggyback the NJPA/Sourcewell State of Minnesota Contract #070121 with Johnson Controls, Inc., for purchasing equipment, parts, installation, and services related to Citywide HVAC and building automation systems. This contract term ends in August 2025.

City staff recommends the approval of this retrofit. Standardizing our building systems reduces operational and maintenance costs, reduces the complexity of dealing with two building management systems, and allows remote visibility and control of the building.

The Fiscal Year 2023 Budget includes available funding in the City's Facilities budget to purchase this service and parts. City staff estimates that the City will expend approximately \$55,970.00 for this service.
