Mayor Alfin called the meeting to order at 6:00 p.m.

#### D PUBLIC PARTICIPATION

Public Participation shall be held in accordance with Section 286.0114 Florida Statutes. And pursuant to the City Council's Meeting Policies and Procedures:

(1) Each speaker shall at the podium, provide their name and may speak for up to 3 minutes.

(2) The Public may provide comments to the City Council relative to matters not on the agenda at the times indicated in this Agenda. Following any comments from the public, there may be discussion by the City Council.

(3) When addressing the City Council on specific, enumerated Agenda items, speakers shall:

(a) direct all comments to the Mayor;

(b) make their comments concise and to the point;

(c) not speak more than once on the same subject;

(d) not, by speech or otherwise, delay or interrupt the proceedings or the peace of the City Council;

(e) obey the orders of the Mayor or the City Council; and

(f) not make any irrelevant, impertinent or slanderous comments while addressing the City Council; which pursuant to Council rules, shall be considered disorderly.

(4) Any person who becomes disorderly or who fails to confine his or her comments to the identified subject or business, shall be cautioned by the Mayor and thereafter must conclude his or her remarks on the subject within the remaining designated time limit.

Any speaker failing to comply, as cautioned, shall be barred from making any additional comments during the meeting and may be removed, as necessary, for the remainder of the meeting.

Members of the public may make comments during the public comment portion of the meeting. Please be advised that public comment will only be permitted during the public comment portions of the agenda at the times indicated by the Chair during the meeting.

Joanne Campos-created a social group when my husband passed away. The club has 75 members. Her job is to find events for this club. Issue with finding transportation. The Historical Society can no longer get a bus from the County Transportation Department. Why can't we do this anymore?

Andrew (did not provide last name)-spoke on allowing chickens in the backyards within City limits. Reclassify chickens as domestic fowl. Requesting what the process would be to change the regulations regarding chickens.

Philip Lowe-wants to move to a less populated area on Old Kings North and put in a barn and regulations for such.

Sky Burn-chickens to be allowed in the limits of Palm Coast.

Vince Ligouri-when we were unincorporated, we allowed all kinds of animals, that is why we incorporated so we did not have to deal with farm animals. Also, requested a change to wildfire mitigation and just state anything over 3 ft. should be cleared.

Bruce Stone-Cimmaron Drive. City traffic engineer stated no speeding is going on; went to courthouse and they did a screen report and stated they are issuing many tickets on Cimmaron.

Loretta Suley-consider putting back in cameras for red lights. Traffic is horrible.

Robert MacDonald-\$100K, golf course, Holland Park, new community center pickleball court, Council raises. Each has caused the taxpayers \$100K plus. Pleaded with Council to put in safety cameras at the parks.

Steve Carr-a service provider stated he will no longer service yards on the east side as it is too dangerous.

James (did not provide last name)-\$85k for a resiliency officer. We need money for our streets. Mobility scooter and signage on our multi-purpose trails. Island Walk 3 way stop signs.

Josh Fagan-chickens to be added to backyards for Palm Coast.

Charlene Warner-chickens.

Gary Kunnas-grass being dumped into the canals.

Ginny Arroyo-chickens and turkeys with babies running around. They are bigger birds. I had chickens in NY, they are quiet. There are food shortages, it would be wise to allow chickens in a proper cage.

# G ORDINANCES FIRST READ

8 ORDINANCE 2023-XX VOLUNTARY ANNEXATION OF AN APPROXIMATELY 62.1 ACRE PARCEL GENERALLY LOCATED ON THE EAST SIDE OF OLD KINGS ROAD APPROXIMATELY 2.5 MILES SOUTH OF STATE ROAD 100

City Attorney Borkert read the title into the record.

Matt Laudi, on behalf of the applicant, provided a handout to City Council on his presentation to Council.

Topics discussed: Advantages to annex into the City, Utility rates outside of city limits, increase in tax revenues as an advantage, lack of commercial piece, entitlements under the PUD.

Applicant stated they would like to annex into the City to utilize City requirements, not County requirements.

#### Public Comment

Robert MacDonald-question to Fire Chief, how much more of a fire load will this put on our firefighters. Local response time from closest station?

Charlie Faulkner-Flagler Beach Polo Club W representative spoke of the current project and entitlements if annex.

Vincent Ligouri-what and who is paying the taxes? How can they present what the taxes will be at this time?

Thomas Cook-current Board Member of the Flagler Beach Polo Club W-reached out to the applicant several years ago when they were going to the County to development to work with us. No olive branch extended from the owner or acceptance to meet. Then found out the Developer had a TRC meeting with the County with a completely different proposed Development. The Polo Club is entitled to some of the entitlements and amenities in the PUD.

Charles Hanger-spoke of the project in opposition. Been through quite a few hurricanes since 1979, one of my concerns is what is the egress access to this community?

Sally Arnold-citizens monitoring development-focused on the SE quadrant of Palm Coast. This is in the heart of what we have been following. Who bears the cost to bringing utilities that far south? Design firm-which design firm? Radiance is right across from the entrance to the Polo Club. Who is paying for the pipes? Colbert Landings has a new owner.

Council held additional discussion on annexing. Topics discussed: Has County denied their development-why run to City?

Adam Mengel from the County was available in the audience.

Motion to table the item was made by Council Member Danko and Council Member Pontieri seconded until we get answers from staff with readvertises the item until a meeting can help. Motion passed unanimously.

Council held a discussion on the case law; Clerk validates the requestor is within Flagler County-how is the Clerk qualified to determine if the requestor is a valid requestor, religious leader definition, threshold for congregation totals.

The Mayor shared how he uses the moment of silence to pray for many.

#### Public Comment

Robert MacDonald-has gone to mass for over 70 years. Holds two places sacred-the church of your choice and your firehouse. This room is not meant for prayer.

Paul Montana-very sad to be here to have to vote to open a Council meeting. We are in a spiritual battle of good versus evil. In favor of prayer to open these meetings.

Mike McElroy-sent a letter to City Council, in favor of invocation.

Caroline Gugginheim-the enemy, satan has succeeded in taking prayer out of schools; supports prayer at beginning of Council meeting.

Maria Somers-supports invocation for the beginning of the Council meetings.

Joseph Farvosky-show leadership, as you go so goes Palm Coast, supports prayer. State meetings are opened with prayer.

Gerry Zuger-don't we pray for our children in many ways? Supports prayer at Council meetings.

Bonnie Henry-church would invite all members of Council to the church events. Your position is important, and she supports prayer.

Nancy Earhart-supports prayer.

Leona Montefiore-supports prayer.

Trevor Nunez-supports separation of church and state. Clarified the facts surrounding the Constitution and the Pledge of Allegiance. Changing the moment of silence to the religious invocation could violate rights.

Dave Lynn-supports prayer.

Vince Ligouri-who would possibly object to prayer to God? Our pledge mentions God, our money has God, all but 4 states have God in their constitutions.

Mary Hampton-supports prayers, spiritual values.

Joel Davidson-supports invocation to begin meetings.

Ed Shah-supports prayer.

Renee Wickowski-supports prayer.

Ginny Arroyo-supports prayer.

*Frank Gerhart-family came to America in 1503 due to religious persecution. Supports prayer.* 

Alan Lowe-supports invocation/prayer.

Kelly Dories-supports prayer.

Carol Shaw-agrees with previous speaker and supports prayer.

Rabbi Shapiro-stressed importance of prayer before your meetings in private. Opposes the invocation at public meetings.

Jaden Chavez-we use prayer when there are natural disasters. Prayer is very important. We have the right to pray. Sad to stand here and state we have the right to pray, etc. Supports prayer.

Carol Gunthorpe-opposes prayer.

Beatrice Enriquez-supports prayer.

Charles Hanger-provided a neutral opinion on the topic. For and against not a venue for religious challenges.

George Somers-supports prayer.

Charlene Warner-separation of church and state is not in the constitution, it was a letter.

Allie Rose-supports prayer.

Council held further discussion on this item. Topics discussed-the pledge, money, religious beliefs, separation of church and state, shared opinion from Speaker of the House from Paul Renner to begin with prayer, personal beliefs of prayer, division amongst all, battles of good vs. evil, respect all regardless of religious beliefs, moment of silence versus invocation, bibles are allowed in school, potential lawsuits with prayer and invocation, and that the vote today does not represent what bucket you are in personally regarding invocation vs. a moment of silence. Council Member Danko made a motion to approve the resolution for the invocation policy (as clarified by the City Attorney). The motion died for a lack of a second.

Council Member Pontieri appreciated one of the comments made regarding the length, made a motion to have the moment of silence be extended, which was seconded by Council Member Klufas.

Opened up again for follow up Public Participation on the newly presented motion.

Charles Hanger-thanked Council for this difficult situation. Asked if you can remember when John F. Kennedy, Martin Luther King, Jr., and Robert F. Kennedy were shot and what you were doing. He remembers when they took prayer out of the schools. He would like to see Council open with public participation first.

The motion was to have the moment of silence extended to one minute. Motion passed 4 to 1, with Council Member Danko dissenting.
