# 2 QUARTERLY REPORT FOR THE PERIOD ENDING DECEMBER 31, 2023

# G ACTUARIAL REVIEW

Mr. Lozen presented the Actuarial Valuation for 10/01/2023 report. He informed the Board that because of the smoothing method used, the investments barely missed the assumption rate. He explained that the minimum required contribution rate slightly increased, but all the required contributions will be covered by the State money. The funded percentage is 132%. Mr. Lozen informed the Board that the money received from the State increased which led to an increased amount into the Share Plan.

Motion by Board Member Delsordo, seconded by Board Member Schroader to approve the valuation as presented. The motion passed unanimously.

Motion by Board Member Delsordo, seconded by Board Member Schroeder to set the expected rate of return at 6% for the next year, the next several years, and the long term thereafter.
